## PUBLIC NOTICE

*Under s3.12(6), after the local law has been published in the Gazette the local government is to give local public notice —*

- (a) stating the title of the local law; and*
- (b) summarizing the purpose and effect of the local law (specifying the day on which it comes into operation); and*
- (c) advising that the local law is published on the local government's official website and that copies of the local law may be inspected*

The Shire of Wyalkatchem Bush Fire Brigades Local Law will come into effect on Friday 2 August 2024.

The purpose of the local law is to regulate the appointment, employment, payment, dismissal and duties of bush fire control officers; the organisation, establishment, maintenance and equipment with appliances and apparatus of bush fire brigades to be established and maintained by the local government; and any other matters affecting the exercise of any powers or authorities conferred and the performance of any duties imposed upon the local government by the Bush Fires Act 1954 that are to be dealt with by a local law.

The effect is that the matters that the *Bush Fires Act 1954* requires to be regulated by local law are dealt with by a local law.

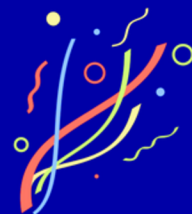
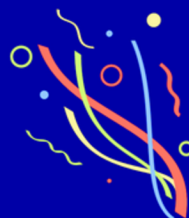
