Restricted Burning Period

8 February 2020 to 22 March 2020

During this time, permits are required to burn. See the following information to see if you need a permit.

PERMIT REQUIREMENTS

RURAL:

- · Permits are to be issued four days in advance of proposed burning;
- If a permit is required with less notice, neighbours are to be notified verbally;
- Department of Parks and Wildlife (DPaW) are to be notified of burning that is within three kilometers of any DPaW Reserve;
- Three people minimum to be in attendance at all times;
- A minimum three metre firebreak:
- Wind speed of less than 15kmph; and
- Fire appliance with a minimum of 600L of water in attendance.

GARDEN REFUSE:

A permit is required to burn garden refuse before 6pm during the Restricted Burning Period, and is subject to the conditions as set out on the permit. Garden refuse may be burnt without a permit after 6pm during the Restricted Burning Period, subject to the following conditions of the **Bush Fire Act 1954** and the **Health Act 1911**.

- The pile of refuse being burnt does not exceed one square metre of area;
- The pile has a five metre wide area clear of flammable material;
- Only one pile is alight at one time;
- The fire is completely extinguished by midnight;
- At least one person in attendance;
- Means of extinguishing the fire are available;
- Neighbours are aware of the intention to burn;
- The smoke does not cause nuisance to neighbours;
- The smoke does not cause traffic hazards;
- No household, commercial or noxious waste to be burnt; and
- No damp, wet or green material at any time.

Smoke from the burning of garden rubbish can cause nuisance and annoyance to other residents. Please consider and plan to minimise smoke.

The Community Grant Program recognises the efforts of community, clubs and other not-for-profit organisations by helping them deliver a diverse range of projects, events, activities and initiatives that contribute to the wellbeing and quality of life for residents of Wyalkatchem.

Councils Community Grant Program - Quick Response Grants is now open, offering funds to support local groups and organisations in the delivery of community projects and events. Council invites applications from community groups and organisations for funding up to \$2,000. Funding priorities will be given to projects that:

- Support volunteers by building the capacity of local clubs and organisations with small equipment purchases;
- Support programs, activities and initiatives delivered by community groups;
- Support community development initiatives;
- Increase the range of events, activities and services within the Shire;
- Provide mentoring opportunities to community organisations to strengthen their organisation; and
- Generate local economic activity, tourism and community development.
