3.0 Confirmation of Previous Meeting Minutes (28 February 2018)

4.0 Business arising from previous Minutes-

4.1 Discussion of OEM report – *Exercise Working Together:* We will look into MoUs for the region – perhaps a discussion for NEWROC to have with WEROC etc.

5.0 Stakeholder Reports

Stakeholders to report on relevant activities.

5.1 Bush Fire Brigades – Ella reported that the annual Local Government Grant Scheme was submitted on time with the assistance of Daniel Hendriksen (DFES Area Officer) – thank you very much to Daniel for all his help.

The applications for the volunteer fuel cards were all successful, cards have been activated.

The 2.4 Broad acre (Wyalkatchem Brigade truck) has been returned – DFES had it to fit crew protection to the vehicle. The temporary replacement truck has been returned.

- **Volunteer Fire & Rescue Service** Emma reported that volunteer numbers had remained steady since the last LEMC meeting. They have had two alarm call outs (both false alarms) and one traffic accident since the last meeting. The HSR is back on site and replacement appliance has been returned. They completed a breathing apparatus refresher course last Monday and structural fire training is scheduled for 21 and 22 April.
- 5.3 St John Ambulance Jay reported that 25 jobs have been completed since the last LEMC meeting. The transportable building in Wyalkatchem is still a work in progress as is the Koorda building the committee meets next week and hopefully some decisions will be made there.

SJA participated in the Wylie Fair on Saturday 7 April – two people were treated with band-aids, no serious injuries. They ran a "CPR competition" which was a big hit. Several of their volunteers have received awards lately, with a special mention to Glyn Harrington who received a Commandery Commendation which is a very prestigious award. Duncan reported that Dowerin are building a sub-centre next door to the new bushfire brigade building – this will hopefully be finished by the field days.

Peter reported that they have been asked to render the sub-centre in Wyalkatchem and paint it in corporate colours in order to make the building more appealing.

- **Police** Tracey reported that she has been trying to get together some maps of the district for emergency management purposes she would prefer everyone work off the same map (i.e. DFES, SJA, WAPOL etc.) Her and Nathan attended the Wylie Fair and reported that it was fantastic.
- **5.5 District High School** Susan reported that there was nothing new to report on the emergency management front all the school's plans have been submitted to the District Office and are all up to date.
- **5 6** Wyalkatchem Koorda District Hospital No report.

- **5.7 Shire of Wyalkatchem –** Nothing new to report (please see Bushfire Brigade report)
- 5.8 Department of Communities Still working on the plans, focusing on the southern Wheatbelt Shires (Narrogin area) as everyone up this way is working on the State Risk Project. Jo was in the Williams area recently and they are having issues with Telstra they may contact us to discuss how we have been dealing with the phone issues during power outages. Bruce Rock had lost power over the Easter weekend for over 48 hours a conversation was had about the possibility of opening an evacuation centre for the elderly as the temperature was only around 30 degrees, it was decided it would be better not to shift people.

 - 5.12 DFES Daniel reported that there was a large storm over Easter, two houses and one church in Trayning lost their rooves no damage to Wyalkatchem luckily. DFES are expecting an announcement on the rural fire service in the next couple of weeks. Mukinbudin become an active road crash rescue brigade as of next Monday.
 - **5.13 OEM** Ella reported that the NEWROC (North Eastern Wheatbelt Regional Organisation of Councils) risk project is progressing well, Koorda has completed their work and Mukinbudin are next, kicking off on the 8 June.

6.0 General Business

- **6.1** Peter enquired about when the contact list was last updated. It was updated in October 2017 and will be done annually. Ella does minor updates as and when required (for example, Nathan Eley was added when he commenced in Wyalkatchem etc.)
- **6.2** Susan mentioned that the CRC are advertising in the Wylie Weekly for nominations for 'Volunteer of the Year' and she encouraged everyone to think about nominating someone.
- **6.3** Quentin reported that he and Ian attended a NEWROC meeting today in Nungarin to officially open the telecommunications project that NEWROC and Crisp Wireless are working on. Melissa Price MP was there and opened the event. There will be 13 towers across the NEWROC Shires and they will be active at the end of April/start of May.
