

Western Australia's *Cat Act 2011* requires:

- cats aged six months and over must be registered
- proof of the cat being sterilised and micro chipped, for example sterilisation certificate or itemised vet bill, must be shown
- you must inform the shire immediately of any change in ownership, the death of cat and any change of address.

If you move to another district, you are required to notify and register the pet with the new local government; however, no further fee is payable for that registration period.

Penalties apply for failing to renew your cat registration(s).
